RM 5 MILLION FROM MISC FOR MEDICAL EQUIPMENT AND ON GROUND SUPPORT TO HELP ERADICATE COVID-19 PANDEMIC

KUALA LUMPUR, 9 April 2020 – MISC Berhad (MISC) announces the direct donations of ventilators, patient monitors and other patient care medical equipment critically required for use in Intensive Care wards amounting to RM2.44 million to Hospital Kuala Lumpur and several other government hospitals listed by the Ministry of Health to provide COVID-19 patients with the required medical support. In addition to medical equipment to government hospitals listed by the Ministry of Health; a further sum of RM410,300 was contributed on 3 April 2020 to Pusat Perubatan Universiti Malaya which was also for medical equipment needed in their Intensive Care wards as well. Pusat Perubatan Universiti Malaya is under the Ministry of Higher Education.

Earlier to the contribution of close to RM2.9 million for medical equipment to hospitals, MISC had on 30 March 2020 contributed over RM2.1 million to MERCY Malaysia's COVID-19 Pandemic Fund to support the international non-profit organisation's effort in mitigating the spread of the COVID-19 virus. MISC's contribution to the said fund will be used primarily for providing medical relief and COVID-19 risk reduction activities for vulnerable communities in Malaysia, which is part of MERCY Malaysia's COVID-19 Strategic Preparedness and Response Plan.

Mr. Yee Yang Chien, President/Group CEO of MISC Berhad said, "The contribution of medical equipment required by hospitals and the donation to Mercy Malaysia's COVID-19 Pandemic Fund, is an expression of our support to help eradicate the deadly COVID-19 virus that has threatened the health and well-being of communities and has even caused the loss of lives in our country. Together, we will show our collective strength and resilience, and get through this."
